## I. News

### 1. Aid Harmonization: Challenges for Civil Society

This newsletter from the International NGO Training and Research Centre (INTRAC) looks at how the [Paris Declaration on Aid Effectiveness](#) affects NGOs as providers of international aid. The declaration urges governments to transfer aid directly into the budgets of poor countries, rather than funding their own development projects. While this could prevent rich countries from using aid as a tool to achieve their own political and economic interests, INTRAC warns that Northern NGOs could lose much of their funding and political influence. Southern NGOs, although benefiting from poor countries' increased aid budget, could lose their political independence since national governments would fully decide which NGOs to fund. ### 2. Social Platform: Social NGOs' Message to the European June Council 2006 on Period of Reflection

Anne-Sophie Parent, President of Social Platform (alliance of European federations and networks of NGOs active in the social sector, promoting social justice and participatory democracy), circulated the letter on position of European social NGOs on the so called 'period of reflection' on the EU constitutional treaty, which EU leaders have held since June last year. Social NGOs are concerned that »this period of reflection has been so far more about killing time before forthcoming national elections than inviting people across Europe to constructively reflect on what an improved constitutional treaty should look like. This approach goes against Social NGOs' belief in the need for more participatory forms of democracy«, which includes regular dialogue with civil society and involving as many people as possible throughout the decision making process. ## II. Funding

### 4. CfP: BCSDN Support to Exchange Activities in the Area of Mobilization of Resources 2006 (deadline: 15.06.2006)

Objective of this CfP is to improve individual/staff and organizational capacities in mediating financial constraints through support of exchange,

backstopping/coaching visits between civil society organizations (CSOs) in SEE in the area of networking, funding, lobbying and advocacy. Exchange and backstopping/coaching visits in the area of networking/partnership, funding, lobbying and advocacy are covered with this CfP and are eligible for funding. Concrete activities that are appropriate for funding (but not exhaustive) might be: on-sight visit to successful examples of EU project and activities; meeting or short workshop/training on formulating a joint EU projects or application; exchange visit on approaching EU, national governments on different issues, etc. BCSDN member organizations are primary beneficiaries and can apply as applicants for funds under this CfP. Other organizations (in partnership with BCSDN members) are also eligible to apply. The overall budget of this project is 5,000 Euro of which 2,000 Euro will go towards support of exchange and 3,000 Euro backstopping/coaching activities. Duration of the project should be between one and four months. Time-frame for realization of the project activities is June-December 2006. A new CfP will be launched in late 2006/early 2007 to support further activities and initiatives. #### **5. CfP:Dutch Ministry of Foreign Affairs-Small Embassy Projects Programme (Matra/KAP) (deadline: 16.06.2006)**

Matra is a major programme run by the Dutch Ministry of Foreign Affairs. It has a wide range of components, and its aim is to support the process of social transformation in Central and Eastern Europe. Matra/KAP Programme seeks in particular to strengthen the fabric of civil society, stressing the importance of cooperation and interaction between private and public bodies. The aims of Matra/KAP are similar to those of Matra as a whole, i.e. development of an open, pluralist, democratic society. One of the main characteristics of Matra/KAP is its focus on small-scale, less spectacular initiatives of the kind that are usually overlooked. Matra/KAP also makes a significant contribution to the expansion of networks, leading to better bilateral relations between the host country and the Netherlands! #### **6. CfP:EC European Year of Workers' Mobility-Pilot Projects (deadline: 17.07.2006)**

The purpose of this CfP is the co-funding of a limited number of pilot projects in order to develop and test innovative instruments which facilitate the geographic and labour market mobility of workers and their families and remove existing obstacles to mobility; and transfer between sectors, regions and countries or mainstream existing successful instruments and practices in the area of mobility. All projects need to evidence a clear European added value and should be able to be reproduced in other contexts. They should involve relevant stakeholders and should have the potential to lead to new policy initiatives. The present call for proposals will be financed by the Employment Incentive Measures (EIM) Programme, and is open to participants from the Member States of the EU. Applications may also be submitted by countries having effectively made a financial contribution to the EIM Programme budget to cover their participation in the Programme for 2006. This concerns specifically countries of the European Economic Area, Romania, Bulgaria, Turkey and Croatia.
